APPENDIX 4: SOCIAL CAPITAL

The DRDGOLD board recognises that the company's social responsibilities – its social licence to operate – is of particular importance given South Africa's turbulent and inequitable social history.

The majority of the communities surrounding our operations require social intervention and we manage our social capital with a view to making a long-lasting difference in people's lives wherever possible.

Although we are committed in our attempts to relieve hardship, improve the quality of life and the opportunities of those whom we reach, we are aware of the limitations of what we can realistically achieve as a mid-tier mining company – and in a milieu where the needs are so extensive and wide-ranging.

However, the board holds fast to the view of good corporate citizenship and believes that by creating small 'pockets of stability and excellence' corporate South Africa can – together – make a significant contribution to ensuring a better future for the generations to come.

CONTEXT: THE PAST 12 MONTHS

Economic growth in South Africa continued in FY2015, as it did in the previous year, to suffer from the effects of the global economic downturn that began in 2007.

Unemployment in South Africa remains a major economic issue - particularly among the youth.

Poor education standards, inadequate service delivery, lack of experience and a shortage of employment opportunities are part of this complex problem. Mainly affecting underprivileged citizens, unemployment has serious social ramifications, and is regarded as a critical national issue.

WHAT WE DO

Our education initiatives in the communities near our operations are discussed elsewhere in the DRDGOLD Integrated Report 2015 and the accompanying appendices, but our social capital initiatives – which are largely community-based are best summarised in the following table:

BEYOND MINING

EBDA does not simply support the mining industry, which is the business of DRDGOLD and its operating company Ergo. Our board and management realises that simply creating jobs is no longer sufficient to solve the problems of unemployment. EBDA has therefore developed a comprehensive skills development initiative to focus on job 'creators', an approach that is central to building longer-term sustainable businesses.

ENTREPRENEURSHIP

An important means of job creation is by the development of small businesses. In order to develop entrepreneurs, EBDA has a service-level agreement with Lepharo that offers a three-year part-time entrepreneurship programme and covers the basic guidelines for small business start-up. The aim of the programme is to empower participants so they are able to establish sustainable small-, medium- and micro-enterprises (SMMEs). Graduates are also offered business coaching and support. Eighty-six SMMEs are currently participating in the incubation programme. Of these, 22 are undergoing training by EBDA as part of their initial entrepreneurial training.

ENTERPRISE CLUBS

The EBDA Enterprise Club programme is another project designed to promote the development of small businesses. The first phase was launched in January 2013 at three secondary schools on the East Rand and was completed successfully. All 36 learners have since successfully implemented revenue-generating projects. The programme was repeated in FY2014 for another 36 learners at the same schools, but the programme was suspended after the death of the facilitator. A new facilitator was appointed in February 2015 and an additional group of 14 school leavers joined the programme at the same time. At the time of writing, learners from the three schools had completed about 60% of the programme. The school leavers are in the final stage of the programme and about to submit their applications for finance.

The programme focuses on the basics of running a small business and includes simulations of business-related issues and problems. Successful entrepreneurs from the local townships also make presentations to the participants. Outside visits are arranged when possible e.g. JSE tour. The purpose of the programme is to instil an understanding of, and passion for entrepreneurship and self-employment. The nine-month programme is followed by a further two-year period of coaching and support.

MATHS, SCIENCE AND ACCOUNTING CENTRE OF EXCELLENCE

DRDGOLD's business relies on engineers and metallurgists and these disciplines require a strong grasp of mathematics and science. There is a critical shortage of school leavers with tertiary-level passes in these subjects in South Africa, and among those a rapidly declining standard of understanding and competence has been measured. These problems are carried forward from the school system into tertiary-level education.

In an effort to address this challenge, EBDA has instituted a Maths, Science and Accounting Centre of Excellence to provide maths, science and accounting support to students and teachers at schools on the East and West Rand.

East Rand:

- Tsakane Secondary School maths, science and accounting;
- Tlakula High School maths, science and accounting;
- Langaville Secondary School maths, science and accounting; and
- Nkambula High School accounting (until June 2014 only).

West Rand

- Namedi High School maths and science; and
- Madibane High School maths, science and accounting; and
- Fons Luminus maths, science and accounting.
